INSTRUCTIONS TO VOTER

The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.

- 1. Verify that there are initials of an election official at the bottom of the ballot.
2. Verify that there are no voting marks on the ballot.
3. Use a pencil or black or blue ink pen to mark the ballot.
4. Fill in the oval completely (●) next to either "FOR" or "AGAINST".
5. Do NOT cross out or erase. If you make a mistake, write "VOID" across the face of the ballot and call the Custer County Clerk for instructions at (308)-872-5701.
6. If Early voting, insert the ballot into the Return Identification Envelope. Complete the Oath, SIGN and seal the Return Identification Envelope. Your ballot will not be counted if your signature is not on the back of the return envelope.
7. Any voter physically unable to sign the envelope must make his/her "mark" and have a witness print the voter's name and then witness signs their name below the signature.
8. Place a 1st class postage stamp on the envelope if returning by mail.
9. Mail or deliver your ballot to the Custer County Clerk, 431 So. 10th Ave, Broken Bow, NE 68822. Your ballot must be in the possession of the Custer County Clerk's Office by November 14th, 2023 at 5:00 p.m..
10. Contact the Custer County Clerk's Office at 308-872-5701 if you have any problems or questions.

School Bond Election Custer County School District 0025 Broken Bow Public Schools

"Shall Custer County School District 0025(Broken Bow Public Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed \$26,500,000 for the purposes of financing the costs of (a) making certain renovations and constructing one or more additions to the District's Middle School/High School and related site improvements, and (b) purchasing certain equipment, furniture and apparatus for such school building and additions; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?"
