## MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

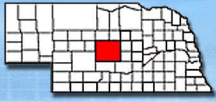
June 14, 2022

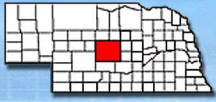

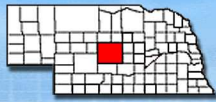

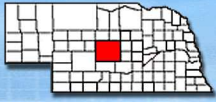

Emory Haynes, Veterans Officer, reviewed the Veterans Board.

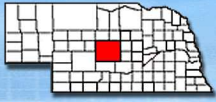
