## MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

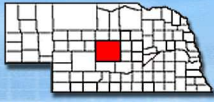
July 12, 2022

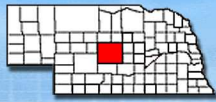

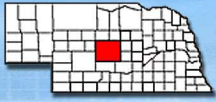

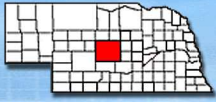
