MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

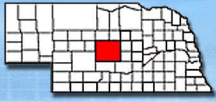
October 11, 2022

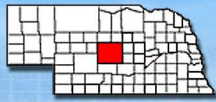

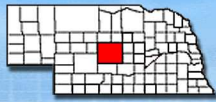

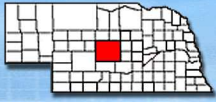
C. Trumbull, Reg of Deeds, discussed rates for copies of records and indexes. Bowers and Trumbull will get back to the Co. Board with a Resolution.
