MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR

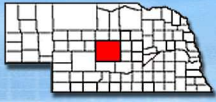
December 27, 2022

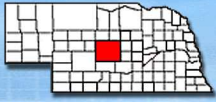

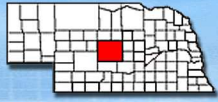

Jacobsen had one application. Motion by Myers, 2nd Olson, to approve an application for CPPD, to install a single phase underground line for stockwell, Rd. 451, S31,T18,R18. Roll call vote. Ayes-all (Weissert-Olson)

Chairman Fox, read the names and reviewed the four resumes received. After some discussion a committee was appointed to review, breakdown the proposals and get back to the board with a recommendation the next regular meeting. Shawn Boyd, Doug Stevenson, Josh Grummet, Adam Goertzen.

Once again, the handbook committee reported on the updates, Osmond discussed the vacation time issue for the variation of hours worked in different offices, and after more calculation and work, some figures for vacation time were presented.
