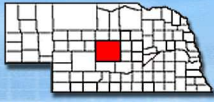
MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR January 10, 2023

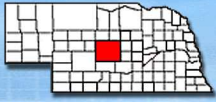

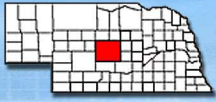

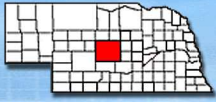
