K. Flynn, Recycling, reviewed and presented his quarterly report for period ending May 30, 2023.

Chairman Fox reviewed the only bid opened for the Front Steps/sidewalk project from Myers Construction. Motion by Longmore, 2nd Gibbons, to reject all bids for the front steps/sidewalk project for the Courthouse. Roll call vote. Ayes-all

Motion by Longmore, 2nd Gibbons, to revise the project and only bid for the front steps construction part of project. Roll call vote. Ayes-all

Motion by Kleeb, 2nd Gibbons, to close the Bids for a Hwy. Dept Pickup at 9:50 a.m. Roll call vote. Ayes-all

Bids were opened from Heartland Chev(no bid);Ernst Auto Center for Silverado-2023-41220.00 and a 2023 GMC-46618.00;Sandhill Motors for a 2022 Ram-50458.00;2023 Dodge Ram-55600.00;Gateway Motors – 2023 Silverado-49887.00.

The Co. Board took bids under advisement and gave to the Hwy Supt. and assistant to review and get back with a recommendation. The Hwy Supt recommendation after reviewing the bidding process was to go with the lowest bid w/Ernst on the GMC , delivery immediately.

Motion by Bryner, 2nd Kleeb, to approve the 2023 GMC 1500, from Ernst Auto Center, Columbus, for \$46,618.00, in stock to deliver. Roll call vote. Ayes-all

Motion by Parliament, 2nd Blowers, to close the bids at 10:00 a.m. for the RM350B-2000 reclaimer. Roll call vote. Ayes-all

A bid was opened from NMC/Cat for \$14,750.00.

Motion by Blowers, 2nd Bryner, to accept the bid from NMC/CAT for \$14,750.00 and drop the repair bill of \$3837.50 for the 2000-RM350B reclaimer. Roll call vote. Ayes-all

Motion by Longmore, 2nd Bryner, to approve an application for Trevor/Cassie Anderson, to go underground for waterline pipe, intersection of Rd.#788 & Rd.#421. Roll call vote. Ayes-all

Motion by Gibbons, 2nd Parliament, to approve an application for Cooksley's Clear Creek Farms, for waterline pipe, ¼ mile south on Rd. #449. Roll call vote. Ayes-all

The Supervisors along with Don Olson, discussed the C&M Agreement with BNSF for the railroad crossing at Anselmo. Co. Attorney Bowers made recommendations for corrections and the Co. Board agreed and directed him to make the changes.

Motion by Gibbons, 2nd Parliament, to table the C&M Agreement until the next regular board meeting and make the changes as discussed. Roll call vote. Ayes-all

Motion by Kleeb, 2nd Parliament, to approve the BC/BS Renewal for FY2023-2024, same deductible amount \$2600.00, same reimbursement. Roll call vote. Ayes-all

T. Walz, Extension Agent, presented the proposed office budget for FY2023-2024, reviewed the line items and answered questions. The budget was taken under advisement.

DHHS contract agreement was reviewed again and decided upon removal of 2.3 and 6.1 and put on next agenda.

The township Disaster Loan renewals were up for discussion. The Co. Board directed the Co. Attorney Bowers to write letters and have them meet before the Co. Board on June 27, 2023. (Arnold, Cliff, Lillian)
