Treasurer to reimburse any subdivision less than 200.00. Roll call vote. Ayes-all

Clerk Gracey presented and reviewed the Preliminary Allocation requests for all subdivisions.

Motion by Kleeb, 2nd Bryner, to approve Res. #25-2024, approving all political subdivision Preliminary Levy Allocations request as presented for FY2024-25, with approval of Corner Township pending on the approval of the 1% restricted funds authority. Roll call vote. Ayes-Parliament, Longmore, Kleeb, Bryner Nays-Gibbons

Motion by Kleeb, 2^{nd} Bryner, to adjourn as the **Board of Equalization** and reconvene as the County Board **at 9:40 a.m.** Roll call vote. Ayes-all

Historical Society's request was reviewed. Motion by Gibbons, 2nd Parliament, to reduce the request by one third, and none in future years. Roll call vote. Ayes-Gibbons, Parliament Nays-Bryner, Longmore, Kleeb Motion Failed

Motion by Bryner, 2nd Longmore, to approve support as requested, \$8500.00 for Custer County Historical Society, and \$8000.00 for Seven Valleys Historical Society, with a notice that this may be the last support. Roll call vote. Ayes-Bryner, Longmore, Kleeb, Nays-Gibbons, Parliament

Motion by Bryner, 2nd Longmore, to authorize Chairman Blowers to sign the Quit Claim Deed to Broken Bow Township on a -2.43 acre piece of ground. Roll call vote. Ayes-all

Motion by Bryner,2nd Parliament, to approve an application for CPPD, to install underground a single phase powerline for new residence. S18/19,T14,R24. Roll call vote. Ayes-all

Jacobsen and Olson reviewed the three options for armor coat and to reject Figgins bid because of increased rates, and the Co. Board suggested asking for bids earlier in year. Motion by Bryner, 2nd Parliament, to reject the Figgins bid for armor coating and go out on open market to get within \$50,000.00 of figure presented for project. Roll call vote. Ayes-all Gibbons-absent

Curtis Stallbaumer, Woodriver Township Treasurer was present to discuss terminating the township board and letting the County take over roads. After much discussion, he will talk to the County Road dept. and get some figures to contract with the County for maintaining the roads.

A Public Comment time was opened.
