- S. Ross, CEDC reviewed the difference in the Pledge amounts. Motion by Gibbons, 2nd Fox, to approve Pledge A-\$3000.00, for 2025 to the CEDC. Roll call vote. Ayes-all

Ross also reviewed for Carla Kimball, CNEDD, the CDBG updated Program Income Guidelines, OOR Housing Grants and made sure all was corrected as requested.

Chairman Blowers, and Bryner, reviewed the East Stairs Project and the differences with the Change Order. Motion by Fox, 2nd Bryner, approve the Certificate of Substantial Completion with Ackerman General Contracting, and Change Order #2 for the Contract Sum to be \$160,000.00 not \$212,444.00 for work completed. S. Bryant, Co. Treasurer reminded the Board of the Federal law to have the ARPA Funds obligated/designated before Dec. 31, 2024. Motion by Fox, 2nd Gibbons, to obligate the last designated ARPA SLFRF Funds of \$27,320.20 to the East Stair Project on the Custer County Courthouse. Roll call vote. Ayes-all

Chairman Blowers and all Board members Thanked Dwain Bryner for his 8 years of service as County Supervisor in District 4.

Chairman Blowers and all Board members extended condolences to the family of the man who lost his life during the recent fires in Broken Bow. They also Thanked the first responders, over 30 departments of fire fighters, citizens who provided food and drink for all the crews and individuals.
