M. Rempe, Emerg. Mgt. presented a After-Action Report/ Improvement Plan to the Co. Board on the Fires in Custer County. Cooksley Fire – approx.. \$174000.00, Complex Fires-\$451,200. Major Strengths and areas of improvement were all covered and all Fire Chiefs have been involved.

Dep. Attorney Clark, J. Markham, Dep. K. Jacobsen and Clerk Gracey met Monday morning and discussed electronic claim filing. Gracey reported on the procedure to file claims and informed the Board that it is not possible to have only electronic filing. A procedure for review will be at the next meeting.

Jordan Arndt, Zelle HR rep. presented/discussed a Request Form to get on the Co. Board's agenda. After much review – corrections/changes will be completed.

Clerk Gracey reported that the Final Audit report for Custer County ending 6-30-2024 has been received and is on file in the Clerk's office, a Notice was published to notify the public that it's available to be viewed.
