C. Jacobsen, Hwy Supt. reviewed the Road Contract with Prairie Hills Wind, LLC, also present were the Algernon and Elk Creek Township board members. This road agreement can also include the townships or just the County. It was unanimous the townships would like to be included with the one road agreement with Custer County.

Jacobsen want directive on the roads in Corner Township – numerous calls have been received and the with the two years of bills(since township board was terminated) the budget is almost gone. Maintenance of about \$1400.00 can be completed.

M. Rempe, Emg. Mgt – informed the Co. Board of a need for fiscal agent in a 21 county district for PET(planning, exercise and training) grants. After discussion of awarded funds and distribution, audits, it was decided to have a meeting between the NEMA, Board of Supervisors, and Emerg. Mgt. Table until next meeting.

Kleeb discussed the CNCAP program and thought the Co. Board should write a letter of support to our Senators. Motion by Kleeb, 2nd Longmore, to approve the Chairman to sign and send a Letter of Support for the Central Nebraska Community Action Partnership program to the Congressman and Senator. Roll call vote. Ayes-all

Shared leave bank was discussed with K. Jacobsen and D. Osmond – wanting to use comp time to be used for donating to the shared leave bank and this will need to be added to the handbook. Motion by Markham, 2nd Parliament, to allow comp time to be donated to the Shared leave bank. Roll call vote. Ayes-all

The Co. Board reviewed once again the option to offer VIP to employees. Motion by Longmore, 2nd Fox, to deny B. Marsh/ offering VIP to Custer County employees. Roll call vote. Ayes-all

Motion by Parliament, 2nd Markham, to go into Closed session to discuss pending litigation, it being necessary for the protection of the public interest, or prevention of needless injury to the reputation of an individual, or for the purpose of discussing strategy regarding pending litigation. Roll call vote. Ayes-all

Chairman Blowers repeated the motion is to go into Closed session at 10:50 a.m., it being necessary for the protection of the public interest, or for the prevention of needless injury to the reputation of an individual, or for the purpose of discussing strategy regarding pending litigation.
