Motion by Parliament 2nd by Gibbons to approve the application from Troy Bredthauer for the installation of culvert and driveway construction 327 ft. north of 79344 Sumner Rd driveway. Roll call vote. Ayes-all

Motion by Gibbons 2nd by Longmore to approve Res 28R-2025 request from Sargent Township to approve request to gate Rd 452 approximately 50 ft east and 2,673 ft east of the intersection of Rd 451 and Rd 452 located in Section 5 – T20N – R18W as allowed under NE Rev. Prairie Hills Wind Project representatives – Mary Burkett and Alex Chandler reviewed with the County Board that permits were extended over the summer to complete FAA approvals according to Burkett. Construction starts now slated for mid-2026, with power flowing in 2028.

Discussion was held on the status of the roof at the DHHS building Supervisor Markham presented three bids from Buffalo Roofing-\$44,111, Ridgeline Exteriors-\$42,003, and Rod Sell Construction-\$39,770. The board will wait to hear from NIRMA if the county will receive any insurance funds. It was decided to wait for spring to install the new shingles.

Motion by Kleeb 2nd by Parliament to approve the August monthly fee reports for the Clerk, Register of Deeds, Clerk District Court, Sheriff, and Recycling. Roll call vote. Ayes-all

Discussion was that Custer County will host the next NACO Central District Meeting on March 19, 2026. The clerk will contact NACO for help setting this up in Kearney.

Continuing discussion was held on funding the Recycling Center. Supervisor Longmore reported he attended Nebraska Recycling Council Annual Conference on September 16 to gather ideas for funding the Center. Possible grant funding was discussed. The Board is in favor of establishing interlocal agreements with area communities to expand funding sources. Some members expressed doubts about communities being willing to help cover the cost for the facility. Markham made motion, 2nd by Gibbons to quit funding operation of the Custer County Recycling Center in six months. Roll call vote Ayes two, Nays three. Motion failed.

Public comment – none

Chairperson Blowers called the meeting to order for a Public Hearing. Motion by Longmore 2nd by Markham, to open a Public Hearing @ 11:00 a.m. to set the Final Tax Request for Custer County for FY2025-26. County Board reviewed and no others were present. Motion by Gibbons, 2nd by Longmore, to close the Public Hearing at 11.05 a.m. Roll call vote. Ayes-all Motion by Gibbons, 2nd by Markham, to approve Resolution #27-2025, setting the Final Property Tax request for Custer County FY2025-2026 at \$8,146,113.49. Roll call vote. Ayes-all
