

MINUTES OF THE CUSTER CO. BOARD OF SUPERVISOR
July 2 & 14th, 2026

The Custer County Board of Supervisors met in regular session on Tuesday, July 14, 2026, in the boardroom of the Custer County Courthouse. Chairman Blowers called the meeting to order at 9:00 a.m. and reported the Open Meeting Laws are posted on the north wall and publication of the meeting notice for the BOE for July 9, 2026. The following board members were present – Blowers, Longmore, Parliament, Markham, Govier, Kleeb, Gibbons, and Kelly Jacobsen, Custer County Clerk.

I, Charles Blowers, Chairman will read the following Agenda and Procedure.

1. Call to Order

This is a formal hearing of the Custer County Board of Equalization called for the purpose of considering valuation protests filed by taxpayers, in accordance with Nebr. Rev. Stat. Section 77-15-1 and the sections that follow.

2. Introduction of Parties

As Provided by law, the Board of Equalization is composed of members of the county board.

Anne Gibbons-Dist#1, Tammy Kleeb-Dist#2, Clay Govier-Dist#3, James Markham-Dist#4, Charles Blowers-Dist#5, Lynn Longmore-Dist#6, Sara Parliament-Dist#7. Also present is the County Assessor, Elise Taylor and County Attorney, Steven Bowers.

3. Taxpayer

The burden of proof in these proceedings' rests on the protesting taxpayer

4. Rulings:

No rulings will be issued on the day of the hearing. At the conclusion of the hearings, the Board will take protests under advisement. Within seven days after a final decision by the board, notice of such action will be furnished to the protester by the County Clerk, as provided by law.

INTRODUCTION**

Pursuant to LB 263, Section 9, the assessor shall submit a plan of assessment, which describes the assessment actions planned for the next assessment year and two years thereafter to the county board of equalization on or before July 31, 2026. The plan shall describe all the assessment actions necessary to achieve the levels of value and quality of assessment practices required by law, and the resources necessary to complete those actions. After the budget is approved by the county board a copy of the plan and any amendments thereto shall be mailed to the Property Assessment Division of the Department of Revenue on or before October 31 each year.

REAL PROPERTY ASSESSMENT REQUIREMENTS

All property in the State of Nebraska is subject to property tax unless expressly exempt by Nebraska Constitution, Article VII, or is permitted by the constitution and enabling legislation adopted by the legislature. The uniform standard for the assessed value of real property for tax purposes is actual value, which is define by law as "the market value of real property in the ordinary course of trade" NE Rev. Stat. 77-112. Reissue 2003)

Assessment levels required for real property are as follows:

- 1) 100% of actual value for all classes of real property excluding agricultural and horticultural land;*
- 2) 75% of actual value for agricultural and horticultural land; and*
- 3) 75% of special value for agricultural and horticultural land that meets the qualifications for special valuation under 77-1344 and 75% of its recapture value as define in 77-1343 when the land is disqualified for special valuation under 77-1347*

GENERAL DESCRIPTION OF REAL PROPERTY IN CUSTER COUNTY

CURRENT ASSESSMENT PROCEDURES FOR REAL PROPERTY

A. Discovery:

The County has zoning and a zoning administrator for the rural areas. The cities and villages have their own zoning within the city limits and sub areas. Before building construction is allowed, the property owner is required to file a permit with the zoning administrator in their area and in turn the assessor is notified. At the beginning of the year each property is reviewed for completion and valued accordingly

B. Data Collection:

The county assessor is required to physically review each property in Custer County within a six-year time period. The county is divided into 6 parts to review a portion to stay within required statues. The data collector travels through the county area, reviewing measurements of each home and outbuildings and taking new pictures. Surveys are left at each improved property asking the property owner information about the interior of the property. In new construction & remodeling the property is inspected outside and with the owner's permission will be inspected on the inside.

C. Approaches to Value:

- 1. Market Approach: sales comparison: Using the sales of the various styles, conditions, and ages, to adjust the depreciation.*
- 2. Cost Approach: The RCN (replacement cost new) is figured with the 2021/2025 Marshal and Swift costing manual.*
- 3. Income Approach: income and expense data collection/analysis from the market is done by the Commercial Appraiser hired to value commercial and industrial properties.*
- 4. Sales of agricultural land are mapped out and when a trend in sales indicate a market area change is required will be the only time areas are changed. One market area is set with soil type boundaries and one with natural boundaries such as rivers.*

On June 1, Notices of valuation changes were mailed to all property owners with property value change and a publication is noted in the local newspapers to notify landowners of value change.

ACTION TAKEN

2026 Review began with the six-year cycle starting with Hayes Twp, Arnold Twp, Cliff Twp, Triumph Twp and Ryno Twp. Also being reviewed are Anselmo, Arnold and Merna Villages. Residential sales were reviewed and statical analysis was complete for the review area. Depreciation tables were updated to keep within the median set by the Nebraska Department of Revenue.

Commercial review began with the six- year cycle starting with Broken Bow and Broken Bow Twp along with pick-up work, data was completed in February 2026 by Central Plains Valuation LLC. Commercial sales were reviewed, and a statistical analysis was complete.

For 2027 Assessment Year

2027 - The six-year review will consist of 1 village Sargent, along with 7 twps. Victoria Twp, Kilfoil Twp, Milburn Twp, Lillian Twp, West Union Twp, Sargent Twp and Corner Twp.

For 2028 Assessment Year

2028 - The six-year review will consist of 2 Villages Ansley & Comstock 8 TWPS, Comstock Twp, Douglas Grove Twp, Garfield Twp, Westerville Twp, Myrtle Twp, Ansley Twp and Algernon Twp.

For 2029 Assessment year

2029 – The six-year review will consist of 2 Village/City Broken Bow City and Berwyn Village. 4 Twps, Broken Bow Twp, Berwyn Twp, East Custer Twp and Elk Creek Twp.

Villages are table driven and regrouped in six valuation groups. Sales in the villages reflected a need to regroup the tables to show consistency from the arm's length residential sales that are reporting in the state sales files.

The village groups are as follows.

1. *BROKEN BOW*
2. *CALLAWAY, ARNOLD & MERNA*
3. *ANSLEY, ANSELMO & SARGENT*
4. *COMSTOCK & OCONTO*
5. *BERWYN & MASON CITY*
6. *RURAL*

Commercial properties filing building permits with the zoning dept. were reviewed by the Central Plains Valuation, LLC and valued.

Parcels with ag land are continually reviewed by the assessor clerks, using Gworks for reference and physical reviews are used.

This concludes the Methodology & Three-Year Plan for Custer County.
